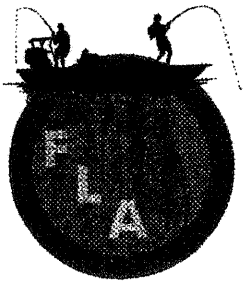

LIABILITY RELEASE
